**2. 2016/2017 City Budgets**

**Adopt each fund budget separately by ordinance.** Mr. Kershaw passed out a memo on the changes to the budgets and asked the Council to quickly review it and see if everything is included that should be. A copy is attached to these minutes and incorporated by this reference.

Mr. Kershaw noted that after all the changes and additions they ended up with about \$100,000 more in the General Fund than they had anticipated. What he proposed in the document tonight is moving that \$100,000 over to the Capital Fund because they have used about \$450,000 in Fund Balance. That now will be \$350,000 and if any of the projects that the Council discussed last night go over budget they put funding back in the bucket that the Council can appropriate based on how the projects pan out.

Council Member Siwik observed that money would get them close to the storm water project at Lincoln Park.

Mr. Kershaw agreed. If the less expensive option doesn't work they are close to being able to fund the other option.
