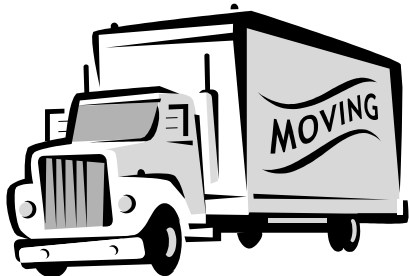

VEHICLE PARKING RESTRICTIONS

USE OF SIDE YARDS SHALL NOT BE INTENDED FOR OFF-STREET PARKING OF VEHICLES OR TRAILERS.

NO CAR SHALL NO CAR SHALL BE PARKED ON A STREET OR ALLEY LONGER THAN SEVENTY-TWO (72) CONSECUTIVE HOURS.

LARGE VEHICLES THAT EXCEED THIRTY-FIVE (35) FEET IN LENGTH OR 30,000 POUNDS GVW ARE NOT PERMITTED TO PARK ON ANY STREET, UNLESS APPROVED BY THE CITY OR MOVING RESIDENTIAL GOODS.

VEHICLES PARKED ON THE STREET WHICH ARE NOT LICENSED AND NOT REGISTERED CONSTITUTE A PARKING VIOLATION.

TRAILERS SHALL NOT BE ALLOWED TO PARK ON STREETS UNLESS ATTACHED TO A LICENSED, REGISTERED, AND OPERABLE VEHICLE.

OFF-STREET PARKING OF VEHICLES OR TRALERS MUST BE ON HARD SURFACED AREAS SUCH AS CONCRETE OR ASPHALT.

PARKING ON SIDEWALKS AND PARK STRIPS IS PROHIBITED.

A MORE COMPLETE LIST OF ON STREET PARKING ISSUES CAN BE FOUND IN THE CITY'S MUNICIPAL CODE.

LIMITED PARKING TIMES

FOLLOW APPROPRIATE SIGNAGE ON STREETS EXCEPT FOR SUNDAYS AND LEGAL HOLIDAYS.

PARKING IN EXCESS OF TWO (2) HOURS BETWEEN NINE (9) AM AND SIX (6) PM IS PROHIBITED ON:

STATE STREET
MAIN STREET
2100 SOUTH STREET

PARKING IS PROHIBITED ON MAIN STREET BETWEEN 2100 SOUTH AND 3000 SOUTH.

WHAT CAN BE DONE?

VIOLATION OF ANY STREET PARKING ORDINANCE MAY RESULT IN A CITATION OR IMPOUND BY A LAW ENFORCEMEN OFFICER.

PARKING ON THE SIDEWALK OR PARK STRIP MAY RESULT IN A CITATION OR IMPOUND.

FOR OFF-STREET PARKING VIOLATIONS, NOTIFICATION AND TIME WILL BE GIVEN TO CORRECT THE PROBLEM. IF THE PROBLEM CONTINUES, A CITATION MAY BE ISSUED.

THE CODE ENFORCEMENT DIVISION

A1 = Area 1: 2100 S – 2700 S, 500 E – 1100 W

A2 = Area 2: 2700 S – 3300 S, 700 E – 1100 W

A3 = Area 3: 3300 S – 3900 S, 700 E – 1100 W
