Matters for Discussion

1. **Animal Code.** Deputy City Attorney, Paul Roberts, conducted a straw poll with the Council regarding various animal limits. The Council was in favor of the following: two dogs and two cats with one additional if the third is a rescued animal; setting the limit for rabbits at six; beehives at three in 4,500 square foot lots or larger; poultry in 6,000 square foot lots or greater; and in favor of cat licensing. With regards to feral cats, the Council was in favor of imposing feeding restrictions without specifically permitting colonies under City law.

Mr. Roberts said he would bring an ordinance back to the Council with these recommendations.

- 2. Alcohol ordinance discussion.** Mr. Roberts explained that staff has created a new sub-category MB for a micro-brewery license. This license would allow the business to sell their product as well as give samples and allow consumption on premise. The alcohol must be manufactured by the licensee. They also have to have food available and the building has to have windows in the front.


Mr. Roberts asked the Council if they wanted such a business to be able to locate within 200 or 600 feet of community locations, which are parks, playgrounds, churches, and schools.

The Council was in favor of the 600 foot rule, having one license per 10,000 residents, with hours of operation until 10:00 p.m. on weeknights and midnight on weekends.


Mr. Roberts advised that staff will get this put together and invite the regulated community to give their comments and then come back to the Council in about a month.

- 3. Urban Livability update.** Urban Livability Director, Glenn Smith, reviewed a power point presentation on what their Department has accomplished the last four years. A copy is attached to these minutes and incorporated by this reference.

The meeting adjourned at 7:02 p.m.
